1. Important information and who we are

2. The types of personal data we collect about you

3. How is your personal data collected?

We use different methods to collect data from and about you, including:

- Direct interactions: when you register for the event, communicate with us by email or phone, or provide information in person.
- Third-party event platforms: such as registration platforms (e.g., Confetti) or payment providers.
- Photography and video: during the event by our official photographers and videographers.

4. How we use your personal data

The law requires us to have a legal basis for processing your personal data. The table below describes how we use your personal data, the categories of data involved, and the legal bases we rely on.

5. Disclosures of your personal data

We may share your personal data with:

- Our event venue/hotel to manage accommodation and catering.
- Sponsors (limited attendee data: name, role, and email).
- Other attendees (limited attendee data: name, role, and email).
- Payment processors.
- Photography and videography service providers.

6. International transfers

We do not transfer your personal data outside the UK or EU.

7. Data security

We store personal data in password-protected systems and restrict access to authorised personnel only.

8. Data retention

We will retain your personal data for up to 2 years after the event. After this period, the data will be securely deleted.

9. Your legal rights
